Barnwell District ---- } In the name of God amin I Jacob Foreman of the State and District afore Said, being Sick and Weak in Body, but of Sound memory reson and understanding, and disposing Mind, but desirous to make a distribution of my Estate, do make and ordain this my last will and Testament, --

First I give devise and bequeath to my Beloved Wife Rachel Foreman, the following Negroes Slaves to wit, Jake, Rose; Mariah, Edmond, Dick, Amy, little Hannah, Robin, Sophy, little Bill, Smith, French Bill, big Hannah, and field Rose, Also my Stock of Cattle, Hogs, Sheep and Three head of Horses, together with the House hold and Kitchen Furniture, All the above named Negroes to be hired out yearly except Field Rose and One Horse to Remain with my wife. Also my beloved Wife and my two grand children, Polley and Evuline Foreman, to be Supported and Schooled out of my present crop the ensuing year, after, that to be Supported and Schooled out of my Estate, during my wifes natural life, Also I give to my Son Jacob Foreman the use of the Land he has foremerly had during his Mothers natural life, Also I give to my Son Glover Foreman the use of the Abraham Turner Tract of Land during his Mothers life, the balance of my lands to be Rented out yearly, except Houses and Garden for the use of my Wife and two grand Daughters Polly and Evuline, -----

Item I give devise, and bequeath after the death of wife unto my Son Jacob Foreman, One proportionable part of my Estate, Real and personal, ---

Item I give devise and bequeath to my Daughter Nancy Heard Ten Dollars, -----

Item I give devise and bequeath after the death of my wife, One proportionable part of my Estate Real and personal to the children of my Dauther Nancy Heard, -----

Item I give devise and bequeath after the death of my wife One proportionable part of my Estate Real and personal unto my two grand Daughters Polley and Evuline Foreman, -----

Item I give devise and bequeath after the death of my wife, One proportionable part of my Estate Real and Personal unto my Son Glover Foreman, -----

Item I give devise and bequeath the Rest and Remainder of my Property if any Such there be at the time of my wifes demise (always excepting the before bequeaths) to be Equally divided between my above named Leggatees. Share and Share alike ----- dated the Tenth day of October 1823 -----
