and he, the said Thomas Gordon (No. 6) is the ancestor who assisted in establishing American Independence, while acting in the capacity of Private Va. 100.

ANCESTOR'S SERVICE

"SECTION 1. Any man shall be eligible to membership in this Society who, being of the age of eighteen years or over, and a citizen of good repute in the community, is the lineal descendant of an ancestor who was at all times unfailing in his loyalty to, and rendered active service in, the cause of American Independence, either as an officer, soldier, seaman, militiaman, or minute man, in the armed forces of the Continental Congress, or of any one of the several Colonies or States, or as a signer of the Declaration of Independence; or as a member of a Committee of Safety or Correspondence; or as a member of any Continental, Provincial, or Colonial Congress or Legislature; or as a recognized patriot who performed actual service by overt acts of resistance to the authority of Great Britain."—Constitution of National Society S. A. R., Article III, Section 1, adopted June 3, 1907, and as amended.

Membership is based upon one original claim; when the applicant derives eligibility by descent from more than one Revolutionary ancestor, and it is desired to file additional claims, separate applications, to be marked "Supplemental Applications," should be made in each case and filed with the original.

By order of the Board of Trustees, May 3, 1911, the recipient of a certificate granted on this application agrees to surrender his certificate upon failure to pay his membership dues, unless his membership shall cease by reason of death or actual disability, to be determined by the Society of which he is a member.

My ancestor's services in assisting in the establishment of American Independence during the War of the Revolution were as follows:

The patriotic response of Thomas Gordon to the Declaration of Independence was made on May 11, 1777, when he left his young wife Sarah Gordon and five year old son John at his home in Albemarle County, Virginia, and voluntarily enlisted in the Grayson 16th Virginia Continental Regiment for a period of three years.

Thomas Gordon was assigned as a private soldier to the company commanded by Captain Cleon Moore, where he served two years. He participated in the battles of Brandywine on September 11, 1777, and Germantown on October 4, 1777, fought under personal direction of General Washington. The winter of 1777-1778 was passed at Valley Forge, Pennsylvania. Here the regiment was given military instruction and training under General Baron von Steuben.

With General Washington's army he spent the winter of 1778-1779 at Camp Middlebrook in Somerset County, New Jersey. Thomas Gordon was transferred to the company in the "Gist Regiment" commanded by Strother Jones. The records of the war department of the United States show that the name of Thomas Gordon last appeared upon payroll of Captain Strother Jones' company during the month of November 1779.

The tradition of Thomas Gordon, junior family is to the effect that Private Thomas Gordon, and fourteen other Continental Soldiers, were captured by the British and held for some time as prisoners of war until rescued by the mounted American Forces. During this imprisonment their wrists were bound by green hickory switches which, when they hardened and dried upon their hands, cut deep wounds leaving scars as permanent reminders of their painful sufferings inflicted by the British Soldiers.
