### The Guthrie Farm on the Wollerton Homestead

## **Research by Estelle Cremers**

In 1999 I contacted Estelle Cremers of Historical Land Research in Pottstown, Pa. to do a Deed Search to document the history of the Guthrie Farm. You will find some words spelled in a different way, but that is the way they spelled them in the 17th and 18th century, according the Estelle Cremers.

The Patent designations simply reflect that the surveyors of the Deed Rolls Office in Philadelphia were a few years behind the political divisions of the county.)

Spackman's Mill, all the land on the West side of said Course (nearly where the partition fence now stands) be it more or less, to be my son John's part of my land"				
	"I Give Devise and Bequeath unto my Son James Wollerton, all and singular the remaining part of my Tract of Land where I now live, which lies to the East of the above said partition Line, which I have now fixed, with all the Buildings and Improvements made on the same, and to his Heirs and assigns forever, and I also Give to my said Son James Wollerton all The reversions and remainder of my				

Estate both real & Personal...."

**AND** the said son, John Wollerton died intestate in 1794 leaving a widow, Mary Gray Wollerton, and issue eight living children.

**AND** Mary Gray Wollerton died in 1795 leaving 8 surviving children all of full are, & naming brother-in-law James Wollerton Co-Executor with her eldest son, William Wollerton.

**AND** James Wollerton died testate in 1805 leaving a widow, Dorcas Few Wollerton, and issue nine living children all of full age, having written his Will the 27th day of February, 1805.

# By Will Papers #5213

James Wollerton of East Bradford d Township: "devise and bequeath unto beloved wife, Dorcus Wollerton, the room Down Stairs, it being the West End of the house, and privilege of Any other part if she should want it and Likewise to have her fir wood Cut and drawed to the door: and Shell have fifteen bushels of rye and ten bushels of Wheat and one hundred and fifty pounds of porke and Fifty pounds of beef Each and Every year During her Natural like and likewise my best Feather Bed and Beding and all my house-hold furniture, and to have A horse Saddle and Bridle and a Cow to be kept winter And Summer and provided for, and to have Sixteen Dollars Each and Every year during her Natural life. (I have a copy of the Will with further bequests to children, which ended with the following bequest to his youngest son, John Wollerton.)

"I give and devise to my Son John Wollerton all and Singular the remaining Part of my track of land where I now lives with all the Building and Improvements maid on the Same, and to his heirs and Assigns for Ever, and I also give to my Son, John Wollerton all the reversions and remainder of my Estate both real and personal he paying the legacies Before mentioned......"

(This son, John, son of James and Grandson of Charles Wollerton, the Patentee, remains on the farm until 1834 when he dies, a widower with four grown children, Mifflin, James, Drucilla, and Albina. His Estate with `150 acres of land is processed through Orphans' Court and is recorded in 1836)

Of the original 57 acres owned by Edwin S. Guthrie over the years 6.18 acres was deed to some his children to build homes. In 1972 at the time the Executors of the Estate sold the 48.82 acres to C. Leon and Billy Rae Guthrie they deeded off the log house and 2 acres to Gustan & Georgeanne S. Hoecht for \$20000.00. Leon and Billy Guthrie actually paid \$76000.00 for the 48.82 acres as the inheritance from Pop Guthrie was \$10000.00 and that went directly to our bank as down payment. In April 1976 Leon and Billy Guthrie bought back the log house and 2 acres from the Hoechts for \$36200.00.
